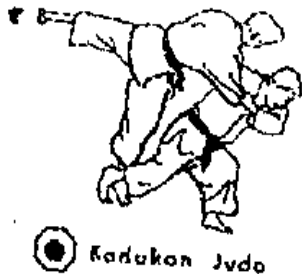
THE AWARDS ARE TO FURTHER THEIR JUDO TRAINING IN LIEU OF TROPHIES.

Make checks payable to **CUPERTINO JUDO CLUB**. There will be a \$25 charge on all returned checks.

ELIGIBILITY: This tournament is open to all male and female registered members in good standing with the **United States Judo Federation (USJF)**, **United States Judo, Inc. (USJI)**, or the **United States Judo Association (USJA)**.

All contestants must present their current valid **USJF**, **USJA**, or **USJI** registration card, with acceptable proof of insurance, at the time of registration. If a contestant is unable to present a current valid registration card, he or she will be required to purchase a membership from one of the three organizations at the tournament site. Responsibility for reimbursement of membership fees for those who have previously registered remains that of the individual.

All contestants must be familiar with the sport of Judo and the rules in connection therewith and have sufficient ability to safely compete in this tournament. Contestants, their parents (in the case of minor contestants), and their instructors have responsibility of ensuring that the contestants meet this requirement.

CATEGORIES: All contestants will be grouped in pools, according to age, size, and rank. Every effort will be made to separate contestants from the same club and to provide competitors with the maximum number of matches with opponents of roughly the same size and ability, although this will not be possible in all cases. Instructors are requested to check pools when called to ensure the safety of their students. If a participant decides not to compete after registration but before actual competition, their entry will be withdrawn and the fee refunded in full.

CONTEST RULES: Modified IJF Contest Rules are follows:

- No Shime-waza (chokes) Jr. Div (under 13 years)
- No double drop-knee Seoinage Jr. Div (under 13 years)
- No Kansetsu Waza (Joint lock techniques) below Shodan division
- Pre 2003 IJF medical rule

Match time: Senior Black Belts – 4 minutes
Intermediates, Senior White and Brown Belts – 3 minutes
Juniors – 2 minutes
Golden Score matches - one minute less than match time.

Awards: Jr. / Int. / Sr. - points > wins > head-to-head* > lowest exponent
Training incentive - wins > points > head-to-head*.

* At the discretion of the referee a run-off may be conducted if contestants aren't previously matched.

AWARDS: 1st, 2nd, and 3rd place trophies for each pool. Place winners must have at least one win. Trophies for all participants in non – black belt pools.

MISC.: Please wear slippers / shoes when walking off the mat area.
No food or drinks in the gym. Seating will be provided in the concession area.

WAIVER AND RELEASE OF LIABILITY AND AGREEMENT TO PARTICIPATE

In consideration of being permitted to participate in any way, including travel to and from, in any Judo tournament, practice, clinic, and related events and activities of the United States Judo Federation, Inc., United States Judo, Inc., United States Judo Association, Inc., Central Coast Judo Association, California Judo, Inc., City of Cupertino, Cupertino Judo Club, Fremont Union High School District, and the Lynbrook High School, I hereby:

1. Acknowledge that I am familiar with the sport of Judo and understand the rules governing the sport of Judo.
2. Agree that, prior to participating, I will inspect the mats, equipment, facilities, competition pools or divisions, and the elimination or scoring system to be used, and if I believe anything is unsafe or beyond my capability, I will immediately advise my coach, supervisor, and/or a tournament official of such conditions and refuse to participate.
3. Acknowledge and fully understand that I will be engaging in a contact sport that might result in serious injury, including permanent disability or death, and severe social and economic losses due not only to my own actions, inactions or negligence, but also to the actions, inactions, or negligence of others, the rules of the sport of Judo, or conditions of the premises or of any equipment used. Further, I acknowledge that there may be other risks not known to me or not reasonably foreseeable at this time.
4. Knowing the risks involved in the sport of Judo, I assume all such risks and accept personal responsibility for the damages following such injury, permanent disability, or death.
5.
